(1) The annual percentage yield assumes interest will remain on deposit until maturity. A withdrawal will reduce earnings.

(2) A CD requires that you leave your principal on deposit for the full term.

(3) Available as investment to be held pursuant to an Individual Retirement Account or Simplified Employee Pension Plan Agreement with the Bank.

(4) Annual percentage yield is calculated based on a 365-day year (366 during leap year).

(5) This rate varies. To determine the current rate, call (860) 859-4300 on any business day or on the maturity date of your certificate.

(6) The interest rate on this type of account is not fixed but can change up or down after you deposit your money.

(7) This rate changes on the last business day of each month to the 182-Day CD Rate on that date.

(8) This rate may change as often as daily at the bank's sole discretion. To determine the current rate, call (860) 859-4300 on any business day.

(9) If the balance falls below the "minimum balance to earn interest", no interest will accrue for those days.

(10) Interim or longer maturities may be available.

(11) Not available to business customers.

(12) The daily balance method is used when computing the payment of interest by applying a periodic rate to the daily balance.

(13) Non-Cash items (Example: Checks) deposited will begin to earn interest from the business day we receive credit for the items.
